In continuation of this office OM.No. CPAO/IT&Tech/Revision (Pre-2006)/Pensioner – delinking of revised pension from qualifying service of 33 years, it is intimated that a clarification has been sought from DP&PW as to whether the OM dated 06.04.2016 is applicable to those Government servants also who had drawn lumpsum payment on absorption in Central Public Undertakings/ Central Autonomous Bodies. As such, the revision of such absorbee pensioners may be put on hold until DP&PW issues the clarification/ separate orders on the issue. A note to this effect has been placed with the list of pensioners to be revised on the basis of DP&PW OM dated 06.04.2016 in the PAO &CCA login provided on CPAO's website i.e. www.cpao.nic.in.

Subject:- Revision of pension of pre-2006 pensioners- delinking of revised pension from qualifying service of 33 years.

Taking into consideration DP&PW OM No. 38/37/08-P&PW (A) dated-06.04.2016, instructions were issued for processing of cases of pre-2006 pensioners by delinking of revised pension from qualifying service of 33 years vide this office OM No. CPAO/IT& Tech/ Revision (Pre-2006)/2016-17/11 dated-12th April, 2016 and subsequent OM No. CPAO/IT &Tech/ Revision (Pre-2006)/2016-17/19 dated-27th April, 2016.

- 2. In this context, DP&PW has clarified the position vide their ID No.38/6/16-P&PW-(A) dated-13.05.2016 that in accordance with CCS Pension Rules, pension is admissible if the retiring/ absorbed employee has completed a qualifying service of 10 years at the time of retirement/ absorption. Therefore, all those pensioners who were drawing monthly pension after completion of 10 years qualifying service before 01.01.2006 are eligible for benefit in term of OM dated-01.09.2008 and 06.04.2016.
- 3. These orders are however, not applicable to those absorbee pensioners who had got 100% lump-sum in lieu of their monthly pension on absorption in PSUs etc. during 1973-1995 and are eligible for restoration of only 1/3rd of their pension in respect of such absorbee pensioners. However, the absorbee pensioners, who are receiving full monthly pension would continue to be covered by the OM dated-01.09.2008 and 06.04.2016 referred to above.
- 4. Further, all Pr. CCAs/CCAs/ CAs/AGs and Administrators of UTs were advised to verify the list of PPO numbers for revision provided by CPAO in their PAOs login, from their records as to whether these PPO numbers are covered by DP&PW OM dated-06.04.2016. The other cases which were not available in the list provided by CPAO but covered under the OM dated-06.04.2016 were also to be revised. It is to ensure that cases of compulsory retirement pension and compassionate allowance under Rule-40 & 41 of CCS (Pension) Rules, 1972 are not to be revised as they are not covered by the OM dated-06.04.2016.

Subject:- Central Civil Services (Leave Travel Concession) Rules, 1988 -Relaxation to travel by private airlines to visit Jammu & Kashmir-Extension reg.

The undersigned is directed to refer to this Ministry's O.M. No. 31011/3/2014-Estt.(A-1V) dated 26th September, 2014 where Government servants in relaxation to CCS(LTC) Rules, were allowed to travel by air to visit Jammu & Kashmir (J&K), North East Region (NER) and Andaman & Nicobar Islands (A&N) on LTC for a period of two years against conversion of one block of Home Town LTC. The relaxation was given subject to air travel by Air India only.

- 2. Later vide DoPT's O.M. of even no. dated 28.11.2014, the Government decided to allow travel by private airlines to visit Jammu & Kashmir under this special dispensation scheme subject to certain conditions. The scheme was valid for a period of one year from the date of issue of the O.M. and expired on 27.11.2015.
- It has now been decided to extend the scheme for a further period from the date 3. of issue of this O.M., till the date of expiry of the of the special dispensation scheme of travel by air to J&K, NER and A&N, i.e. 25.09.2016. All other terms and conditions prescribed in this Department's O.M. dated 28.11.2014 shall continue to apply.

Sub: Clarification on facility of concessional retention of General Pool Residential Accommodation at the last place of posting to Central Government employees transferred to NER, Sikkim, Andaman & Nicobar Islands, Lakshadweep and to the State of J&K.

The concessional retention of General Pool Residential Accommodation (GPRA) to Central Government Civilian employees has been permitted at their last place of posting vide the Directorate of Estates OM No: 12035/31/96-Pol.II dated 7.9.1998 and OM No: 12035/2/90-Pol.II(Pt.II) dated 15.9.1998 on their transfer to NER, Sikkim, Andaman & Nicobar Islands, Lakshadweep and to the State of J&K. It has been brought to notice that some Central Government employees who have come on deputation to Delhi and other places and whose parent Offices are located in NER, Sikkim, Andaman & Nicobar Islands, Lakshadweep and to the State of J&K, on repatriation to their parent Office/Unit request for the facility of concessional retention of GPRA at the last place of deputation.

2. It is clarified that the facility of concessional retention of GPRA at the last place of posting for Central Government employees is permitted only when the allottee of GPRA is transferred to NER, Sikkim, Andaman & Nicobar Islands, Lakshadweep and to the State of J&K from other places and is not permitted to the Central government employees who are repatriated back to his/her parent office in NER, Sikkim, Andaman & Nicobar Islands, Lakshadweep and to the State of J&K on completion of their deputation from other places.

Subject:- -

References from Ministries/Departments seeking advice of the DoP&T regarding further course of action to be taken on the order of Tribunal /Courts.

The Ministries/ Departments make references to this Department seeking advice regarding the course of action to be taken on the order of Tribunal / Courts. Generally, if the directions of the Tribunals / Court is not in consonance with the policy of DoP&T, the administrative Ministry / Department concerned is advised for filing an appeal / review in the High Court in consultation with the Department of Legal Affairs. In a few of these cases, the advice of the Department of Legal Affairs is contrary to the advice of the DoP&T. Under such circumstances, the administrative Ministries / Departments make a second reference to DoP&T and DoLA for resolving the matter. The matter has been considered in the DoP&T and it also discussed with DoLA and representatives of Department of Revenue, Ministry of Health & Family Welfare, who have in the recent past made a few references of this type. In order to avoid second reference and to effectively deal with Court Cases, it has been decided that the following course of action may be followed:-

- (a) Wherever the direction of the Tribunal or court is not in consonance with the policy of DoP&T, the DoP&T may not insist on the Administrative Ministry obtaining the advice of Department of Legal Affairs.
- (b) In all the cases filed in Tribunals/Courts, the administrative Ministry shall defend the policy of DoP&T as laid in various OMs and instructions by filing an appeal or review in the appropriate court.
- (c) The Ministry of Law and Justice to designate a counsel for each Ministry so that the court cases are defended well.
- (d) The Administrative Ministry / Department must ensure that an officer of the level of Under Secretary or above is present in the court when important issues having policy issues or contempt petitions come up for hearing in the court.
- (e) Where necessary, DOP&T while giving advice on the references pertaining to court cases, will indicate that an officer of DOP&T shall be co-opted for briefing ASG. In such cases, the administrative Ministry/Department shall fix an appointment with ASG and inform this Department in advance accordingly (i.e., venue, date and time).
- (f) Wherever there is a case of delay, the Administrative Ministry may fix responsibility for the same.

2. While defending court cases, as far as possible the DoP&T, Ministry of Law and line Ministry / Department should be on the same page and put up arguments on behalf of Union of India in a coherent manner and uphold the policy of the Government applicable in the relevant case.
