Most of the Kendriya Vidyalayas while preparing the receipt and payment account have shown only the net fees collected towards the VVN in the Cash Book.

This resulted in under statement of income of the Kendriya Vidyalayas and the accounts are not exhibiting the true and fair view of the financial position of the Kendriya Vidyalayas. connection, all the Kendriya Vidyalayas while preparing the Cash Book have to follow the procedure suggested below:-

- i) All the Kendriya Vidyalayas should show only the total VVN fees collected in the receipt side of the VVN Cash Book.
- ii) The amount remitted to the Regional Office for VVN deposit account, Regional Sports Control Board Contribution, National Sports Control Board Contribution and remittance to the K.V.S. (HQ) on the payment side of the Cash Book.
- iii) The detailed illustration regarding the fee collections are projected on overleaf.

You are requested to issue necessary instructions to all the Kendriya Vidyalayas under your jurisdiction for making proper entries of VVN fee in the Cash Book for the financial year 2014-15 and 2015-16.
