- The training fee approved is for individual participants from govt. / non-govt. CBSE Schools in any training Programmes conducted by KVS.
- In case of any training programme / course to be conducted exclusively for any non-KV school/schooling system, the training fee will be charged for a minimum of 30 participants with a pro-rata increase in case of increase in number of participants.
- Service Charges to be levied as per Govt. rules.
- If any separate visit is to be made to the school by faculty in preparation of any training programme exclusively for a particular school/schooling system, or any outside experts are invited, their TA/DA would be paid by the School/schooling system concerned, on actual basis.
- Lodging & Boarding charges, if any, are to be collected separately from the participants / organizations on actual basis.
